



## **YCAGA AMATEUR MATCH PLAY** **CHAMPIONSHIP**

- **USGA RULES APPLY TO ALL MATCHES.**
  - **IT IS RECOMMENDED THAT ALL PARTICIPANTS REVIEW RULE 2 – MATCH PLAY IN THE USGA RULE BOOK.**
- **18 HOLES INDIVIDUAL MATCH PLAY – SCRATCH.**
- **MATCHES PLAYED FROM CHAMPIONSHIP TEES.**
- **SEEDING OF PLAYERS - THE FIRST 12 PLAYERS FROM THE WAR OF THE ROSES POINT TOTALS OF THE PRIOR YEAR WILL BE SEEDED 1 -12. ALL REMAINING SEEDS WILL BE DONE BY HANDICAP INDEX AS OF APRIL 1 CURRENT YEAR.**
- **PLAYERS MUST PLAY OUT OF A MEMBER CLUB OR BE A RESIDENT OF YORK COUNTY WITH A VALID USGA HANDICAP.**
- **PURSE TO BE DETERMINED BY NUMBER OF ENTRIES WINNER SHARE IS A MINIMUM OF \$500.00 BASED ON A FIELD OF 32 PLAYERS AND AN INVITATION INTO THE CHAMPION OF CHAMPIONS.**
- **THE COMMITTEE WILL ASSIGN WHERE EACH MATCH WILL BE PLAYED.**
- **PLAYERS WILL PLAY THEIR MATCHES ACCORDING TO USGA RULES AND THE LOCAL RULES SET FORTH BY THE CLUB ON THE DAY OF THE MATCH.**

- **ANY RULINGS DURING A MATCH SHOULD BE ADDRESSED BY THE GOLF PROFESSIONAL OF THE COURSE BEING PLAYED. THE TOURNAMENT COMMITTEE SHOULD BE NOTIFIED IN THE EVENT OF ANY FURTHER DISCREPANCIES.**
  
- **PARTICIPANTS WILL BE CHARGED AN ENTRY FEE OF \$55.00**
  - **PARTICIPANTS WILL ALSO BE CHARGED A FLAT FEE OF \$25.00 PAYABLE TO THE CLUB WHERE THE MATCH IS BEING PLAYED, WHICH WILL INCLUDE A GOLF CART FOR EACH MATCH PLAYED.**
  
  - **CARTS ARE NOT MANDATORY HOWEVER YOU WILL STILL PAY THE \$25.00 FLAT FEE EVEN IF YOU DECIDE NOT TO USE A GOLF CART.**
  
  - **IF YOU WISH TO BRING AN ADDITIONAL PERSON ALONG TO OBSERVE THE MATCH, YOU SHOULD CLEAR IT WITH YOUR OPPONENT PRIOR TO THE TIME OF THE MATCH.**
  
- **THE COURSE WHERE THE MATCH IS TO BE PLAYED MUST BE CONTACTED A MINIMUM OF THREE DAYS IN ADVANCE OF THE DATE THE MATCH IS TO BE PLAYED, TO ARRANGE FOR TEE TIMES**
  
- **ANY PROBLEM SCHEDULING A MATCH MUST BE BROUGHT TO THE ATTENTION OF THE COMMITTEE IMMEDIATELY.**
  
- **MATCHES MUST BE COMPLETED BY THE DEADLINE. **THERE WILL BE NO EXCEPTIONS!****
  
- **THE TOURNAMENT COMMITTEE HAS ESTABLISHED A 3:00 PM START TIME ON THE DATE OF THE ROUND DEADLINE FOR ALL MATCHES. MATCHES MUST BE PLAYED AT THIS TIME OR ANY TIME PRIOR.**
  
- **IF YOU CAN NOT AGREE ON A TIME TO PLAY THE MATCH, YOU MUST SHOW UP AT THE DESIGNATED COURSE AT 3:00 PM ON THE ROUND DEADLINE DATE. IF BOTH PLAYERS SHOW UP, THE MATCH MUST BE PLAYED. IF ONLY ONE PLAYER SHOWS UP, HE WILL BE DECLARED THE WINNER. IF NEITHER PLAYER SHOWS UP BOTH PLAYERS WILL BE DISQUALIFIED.**
  
- **BOTH PLAYERS WILL BE DISQUALIFIED IF MATCH IS NOT PLAYED. (DOES NOT MATTER WHO IS AT FAULT).**

- **THE WINNER OF EACH MATCH IS RESPONSIBLE FOR REPORTING THE RESULTS TO ONE OF THE CONTACTS LISTED BELOW BY 12:00 PM ON THE DAY FOLLOWING THE MATCH. FAILURE TO REPORT THE RESULTS MAY RESULT IN DISQUALIFICATION. THE TOURNAMENT COMMITTEE WILL NOT CALL TO TRACK DOWN RESULTS.**
